**AMENDMENT NO. 3 / THIRD EXTENSION TO THE AGREEMENT
FOR PROFESSIONAL SERVICES**

THIS AMENDMENT entered into this 10th day of June, 2022 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **CDM SMITH, INC.**, a Foreign Profit Corporation, whose principle office address is located at 75 State Street, Suite 701, Boston, MA 02109 (hereinafter referred to as "Consultant").

WHEREAS, on June 12, 2017, the County and the Consultant entered into the Agreement for Professional Services for construction engineering inspection (CEI) services; and

WHEREAS, the Agreement provided for an initial performance period of three (3) years beginning June 12, 2017 and ending June 11, 2020, with an option to extend upon mutual agreement between the Consultant and the County; and

WHEREAS, the parties amended the Agreement extending the performance period for additional one (1) year periods beginning June 12, 2020 and ending June 11, 2022; and

WHEREAS, the parties desire to amend the Agreement for an additional six (6) month period beginning June 12, 2022 and ending December 11, 2022.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Article 4 of the Agreement dated June 12, 2017, the performance period is hereby extended for an additional six (6) months beginning June 12, 2022 and ending December 11, 2022.
2. All other provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
