- 1. <u>Recitals</u>. The Recitals set forth above are true and correct and incorporated herein by reference.

- 2. <u>Assignment and Assumption of Public School Concurrency Proportionate Share Mitigation Agreement</u>. Assignor hereby assigns, quit claims and releases to Assignee, and Assignee hereby assumes from Assignor, all rights, obligations and responsibilities of Assignor under the Agreement.
- 3. <u>Unconditional</u>. This Assignment is unconditional and irrevocable with respect to the parties.
- 4. <u>Further Assurances</u>. Each of the parties agrees to perform such other acts, and to execute, acknowledge, and deliver subsequent to this Assignment such other instruments, documents and other materials, as the other party may reasonably request in order to effectuate the consummation of the Assignment.
- 5. <u>Successors and Assigns</u>. This Assignment shall inure to the benefit of the parties and their respective successors and assigns.
- 6. <u>Consent and Joinder</u>. By execution of the consent and joinder below, the Nassau County School District and Nassau County, Florida, each hereby join in this Assignment for the sole purpose of acknowledging and consenting to this Assignment.
