FIRST AMENDMENT TO CONTRACT FOR FIRE EQUIPMENT, SUPPLIES, AND UNIFORMS

THIS AMENDMENT made and entered into this ______ and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida, hereinafter referred to as the "County", and North America Fire Equipment Co,Inc. whose office address is located at 1515 W. Moulton St. Decatur, AL 35601 hereinafter referred to as "Vendor".

WHEREAS, the parties entered into a Contract on or about November 7,2022; and

WHEREAS, the Contract provided for an initial performance period from November 7,2022, the date of execution, through July 31,2023 with the option to extend the performance period, if necessary; and

WHEREAS, the County has determined it to be necessary to extend the performance period of the Contract through July 31,2025; and

WHEREAS, the County has determined it to be necessary to increase the amount of compensation by Twenty-Five Thousand Dollars and 00/100(\$25,000.00) to account for the extension of the performance period increasing the total not-to-exceed amount of the Contract to Forty-Five Thousand Dollars and 00/100 (\$45,000.00).

- The Contract shall be amended to extend the performance period through JULY 31, 2025.
- 2. The Contract amount shall be increased by Twenty-Five Thousand Dollars and 00/100(\$25,000.00) for a total Contract amount that is not-to-exceed Forty-Five Thousand Dollars and 00/100(\$45,000.00).
- 3. All other provisions of the Contract not in conflict with this Amendment shall remain in full force and effect.
