FIRST AMENDMENT TO CONTRACT FOR PROFESSIONAL SERVICES

THIS AMENDMENT made and entered into this <u>12th</u> day of <u>June</u>, 2023 by and between the **Board of County** Commissioners of Nassau County, Florida, a political subdivision of the State of Florida, hereinafter referred to as the "County", and **Cellet Travel Services**, LTD., located at Bloxham Mill Business Centre, Barford Rd. Bloxham Banbury, Oxfordshire OX15, hereinafter referred to as "Consultant".

WHEREAS, the parties entered into a Contract on or about February 1, 2023 ("Contract"); and

WHEREAS, the Contract provided that Consultant shall be compensated not to exceed Two Hundred Forty-Eight Thousand and Three Hundred Dollars (\$248,300.00) in accordance with Exhibit "A" of the Contract which provides a list of estimated projects and budgets; and

WHEREAS, the parties agree that based on an evolving market demands and program adjustments, the breakout of the programs and budgets shall be viewed as general guidelines and nothing shall preclude an adjustment in programs as needed to meet the overall intent of the Contract subject to the limitations or compensation set forth in Article 5 of the Contract; and

WHEREAS, the parties now desire to memorialize their understanding pursuant to the terms of this Amendment.

NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the parties hereto do mutually agree as follows:

1. Section 5.1 of Article 5 - Compensation of the Contract shall be modified to read as follows:

5.1 Consultant shall be compensated not to exceed Two Hundred Forty-Eight Thousand and Three Hundred Dollars (\$248,300.00) in general accordance with the Total Activity and Total Coordination Fees as provided in Exhibit "A". The final determination of projects shall be at the discretion of the TDC Managing Director.

All other provisions of Article 5 - Compensation and the 2. Contract not in conflict with this Amendment shall remain in full force and effect.
