

## ADDENDUM NO. 2 TO ASPHALT AND STRIPING SERVICES CONTRACT

THIS ADDENDUM NO. 2 TO THE ASPHALT AND STRIPING SERVICES CONTRACT (hereinafter "Addendum") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and Hubbard Construction Company, a business having its primary business location at 1936 Lee Road, Suite 300, Winter Park, Florida 32789 (hereinafter the "Vendor").

#### WITNESSETH:

**WHEREAS**, the Parties entered into a Contract for Asphalt and Striping Services dated June 26, 2023 (hereinafter "Contract"); and

**WHEREAS**, the Parties likewise executed Addendum Number 1. to the Contract dated June 26, 2023, to include the provision for manhole risers and valve box adjustments as part of the contracted Asphalt and Striping Services under the Contract; and

**WHEREAS**, the Parties now desire to further amend the Contract to include the provision for leveling as part of the contracted Asphalt and Striping Services subject to the terms and conditions contained herein.

**NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

**SECTION 1.** Exhibit "A" of Contract No.: CM3359 is hereby amended to include the following immediately after the section entitled "Milling (All Areas), 7.1, Milling":

10.1	Leveling (0.50" Min. Depth)	TN	\$213.60	

**SECTION 2.** Exhibit "B", Scope of Work, of Contract No.: CM3359 is hereby amended to include the following services:

Leveling should be performed on roads where excessive rutting or an "overbuild" to the road edge is needed prior to the overlay layer. Pricing is to include all cost for labor and materials to place and compact the leveling course of asphalt.

**SECTION 3.** In no event will the cost to County for the services to be provided herein exceed the maximum sum of \$30,000,000.00.

**SECTION 4.** All other terms and conditions of the Contract not inconsistent with the provisions of this Addendum shall remain the same and in full force and effect.

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, County of Nassau (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

## Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

## Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. ## Consequences of changing your mind

## All notices and disclosures will be sent to you electronically
