

SECOND AMENDMENT TO CONTRACT FOR ALTERNATIVE PAVING METHODS

THIS AMENDMENT TO THE CONTRACT FOR ALTERNATIVE PAVING METHODS (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and Asphalt Paving Systems, Inc., a business having its primary business location at 9021 Wire Road, Zephryhills, Florida, 33540 (hereinafter the "Vendor").

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for Alternative Paving Methods dated July 12, 2021 (hereinafter "Original Contract"); and

WHEREAS, on April 10, 2023 the Parties entered into the First Amendment to the Contract for Alternative Paving Methods (collectively with the Original Contract hereinafter "Contract") to increase the unit prices; and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

NOW, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

SECTION 1. Section 19. of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year and the Contract shall now terminate on September 30, 2024.

SECTION 2. All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.

This Work Authorization is to the AGREEMENT between Nassau County and Asphalt Paving Systems, Inc. ("Vendor") for Alternative Paving Methods, dated July 12, 2021. The services to be provided under this Work Authorization are as follows:

ARTICLE 1. Services Described as:

Vendor shall provide a double chip seal treatment to the 2023-2024 list of prepared roads in accordance with the Project Proposal, a copy of which is attached hereto as Exhibit "A".

ARTICLE 2. Time Schedule

Vendor anticipates their earliest starting date to be thirty (30) days from receipt of execution of this Work Authorization and the completion date to be no later than September 30, 2024, to complete the Scope of Work.

ARTICLE 3. Budget

Vendor will perform the services outlined herein for the lump sum amount of Four Hundred Thousand Eighty-Four, Nine Hundred Sixty-Seven Dollars and 11/100 (\$484,967.11). Vendor will be using rates previously established under Contract CM3015, and any amendments thereto.

ARTICLE 4. Other Provisions

The Services covered by this Work Authorization will be performed in accordance with the provisions set forth in the AGREEMENT referenced above and any of its attachments or schedules. Additional terms or contract provisions whether submitted purposely or inadvertently, shall have no force or effect. This Work Authorization will become a part of the referenced AGREEMENT when executed by both parties.

Any Work Authorization entered into prior to expiration or termination set forth in the AGREEMENT shall continue in effect through the earlier of: (i) the date all of the Services thereunder have been fully completed and accepted by Nassau County, or (ii) until such time as such Work Authorization expires or is terminated in accordance with its terms or is terminated pursuant to Article 2 hereof.

In presenting this Work Authorization, Vendor agrees that:

Unless detailed herein, all drawings, data, electronic files and other information required for this Work Authorization has been accepted by Vendor. Specifically, all electronic files have been reviewed and accepted for the purposes of this Work assignment. Any additional information, including detailed scope of services are attached.
