AMENDMENT TO CONTRACT FOR LIMEROCK MATERIAL

THIS AMENDMENT TO THE CONTRACT FOR LIMEROCK MATERIAL (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and Liberty Trucking LLC, a business having its primary business location at 9678 FL-121, Lake Butler, Florida, 32054; and whose mailing address is P.O. Box 626, Lake Butler, Florida, 32054 (hereinafter the "Vendor").

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for Limerock Material dated March 13, 2023 (hereinafter "Contract"); and

WHEREAS, the Contract was not formally amended to further extend the performance period, but the Parties continued to perform their contractual duties and responsibilities under the Contract, and the Parties agree by this performance there was an implied extension of the performance period of the Contract; and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

- NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:
- **SECTION 1.** Section 20. of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year and the Contract shall now terminate on March 12, 2025.
- **SECTION 2.** Section 2. of the Contract is hereby amended to increase the not to exceed compensation amount as a result of the Contract term extension and the addition of services and/or materials for the County's Dirt Road Enhancement Project (approximately \$200,000.00 annually) and the County shall now compensate the Vendor in an amount not to exceed Four Million Dollars and 00/100 (\$4,000,000.00).
- **SECTION 3.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
