FIRST AMENDMENT TO CONTRACT FOR DEREMER STUDIOS, LLC SERVICES

THIS FIRST AMENDMENT TO THE CONTRACT FOR DEREMER STUDIOS, LLC SERVICES (hereinafter "Amendment") is made by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida (hereinafter the "County"), and DEREMER STUDIOS, LLC, a business having its primary business location at 7040 Valley Crest Court, Jacksonville, FL 32277 (hereinafter the "Vendor").

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for photography and video services dated September 11, 2023 (hereinafter "Contract"); and

WHEREAS, pursuant to Resolution 2023-135, the AITDC previously recommended and pursuant to Resolution 2023-142, the BOCC approved the ability to amend the Contract as set forth below; and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

- **NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:
- **SECTION 1.** Section 6 of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year and the Contract shall now terminate on September 10, 2025.
- SECTION 2. Section 5 of the Contract is hereby amended to increase the compensation by Forty-Two Thousand, Nine Hundred Dollars and 00/100 (\$42,900.00) and the County shall now compensate the Vendor in an amount not to exceed Eighty-Five Thousand, Eight Hundred Dollars and 00/100 (\$85,800.00).
- **SECTION 3.** Exhibit "A" of the Contract shall be amended to include the Scope of Services for FY25, a copy of which is attached hereto as Exhibit "A".
- **SECTION 4.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
