## STATE REVOLVING FUND AMENDMENT 2 TO LOAN AGREEMENT DW450511 AMERICAN BEACH WATER AND SEWER DISTRICT

The Department and the Project Sponsor entered into a State Revolving Fund Loan Agreement, Number DW450511, as amended; and

Loan repayment activities need rescheduling to give the Project Sponsor additional time to complete construction; and

Certain provisions of the Agreement need revision.

The Parties hereto agree as follows:

- 1. Unless repayment is further deferred by amendment of the Agreement, Semiannual Loan Payments as set forth in Section 10.05 shall be received by the Department beginning on October 15, 2025, and semiannually thereafter on April 15 and October 15 of each year until all amounts due under the Agreement have been fully paid.
- 2. The items scheduled under Section 10.07 of the Agreement are rescheduled as follows:
  - (2) Completion of Project construction is scheduled for April 15, 2025.
- (3) Establish the Loan Debt Service Account and begin Monthly Loan Deposits no later than April 15, 2025.
- (4) The first Semiannual Loan Payment in the amount of \$12,729 shall be due October 15, 2025.
  - 3. All other terms and provisions of the Loan Agreement shall remain in effect.
