FIRST AMENDMENT TO CONTRACT FOR BEACH AND PARK RESTROOM CLEANING SERVICES

THIS FIRST AMENDMENT TO THE CONTRACT FOR BEACH AND PARK RESTROOM CLEANING SERVICES (hereinafter "Amendment") is made by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida (hereinafter the "County"), and GREENSCAPE ENTERPRISES, INC., d/b/a BORO BUILDING & PROPERTY MAINTENANCE, a business having its primary business location at 6321 Porter Road Suite 5, Sarasota, Fl, 34240 (hereinafter the "Vendor").

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for Beach and Park Restroom Cleaning Services dated March 10, 2025 (hereinafter "Contract"); and

WHEREAS, the County's Request for Proposal No. NC24-028-RFP, in its Price Sheet, incorrectly referred to "In-season" as October 1 to February 28, and "Off-season" as March 1 to September 30, when they should have been reversed, with "Off-season" being October 1 to February 28, and "In-season" being March 1 to September 30; and

WHEREAS, Vendor provided rates and estimated costs per year based on the Price Sheet as written, which Price Sheet was incorporated into the Contract as Exhibit "B"; and

WHEREAS, the Parties now desire to amend the Contract terms and conditions to accurately identify the "In-season" and "Off-season" rates, subject to the provisions contained herein.

- **NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:
- **SECTION 1.** Section 4.1 of the Contract is hereby amended to increase the compensation amount for the goods/services to be provided under the Contract by \$4,500, to an amount not to exceed NINETY-SIX THOUSAND SEVEN HUNDRED FIFTY AND 00/100 DOLLARS (\$96,250.00) per year for the term of the Contract.
- **SECTION 2**. Exhibit "B" to the Contract, consisting of the Vendor's Price Sheet, is hereby replaced with the corrected Price Sheet, attached hereto and incorporated herein as Exhibit "B-1".
- **SECTION 3.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
