#### SECOND AMENDMENT TO CONTRACT FOR KITCHEN HOOD AND DRYER DUCT CLEANING SERVICES

THIS SECOND AMENDMENT TO THE CONTRACT FOR KITCHEN HOOD AND DRYER DUCT CLEANING SERVICES (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and **Kept Companies, Inc.**, a business having its primary business location at 26 Law Drive, Section E, Fairfield, New Jersey, 07004 (hereinafter the "Vendor").

#### WITNESSETH:

**WHEREAS**, the Parties previously entered into a Contract for kitchen hood and dryer duct cleaning dated May 5, 2023 (hereinafter "Contract"); and

**WHEREAS,** on or about March 29, 2024, the County received notification of the Vendor's name change to Kept Companies, Inc. d/b/a Fleetwash; and

WHEREAS, on April 11, 2024, the Parties amended the Contract to reflect that change; and

**WHEREAS,** the Vendor has now notified the County of an additional name change from Kept Companies, Inc. dba Fleetwash to Kept Companies, Inc.; and

WHEREAS, the County likewise recognizes the Vendor's name change and consents to the assignment and thereby transfers and assigns to the Vendor all the rights interests, and obligations of the Contract Agreement numbered CM3377; and

**WHEREAS**, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

**NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

**SECTION 1.** The above recitals are true and correct and are incorporated herein, in their entirety, by this reference.

**SECTION 2.** Section 20. of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year. The Contract shall now terminate on May 4, 2026.

**SECTION 3.** Section 4 of the Contract is hereby amended to increase the compensation amount for the goods/services by Ten Thousand, Four Hundred Twenty-Five Dollars and 00/100 (\$10,425). The County shall compensate the Vendor in an amount not to exceed Thirty Thousand Two Hundred and Eighty-Five Dollars and 00/100 (\$30,285.00).

**SECTION 4.** Upon execution, renewal or extension of this Contract, the Consultant shall provide the County on a form approved by the County an affidavit signed by an officer or a

representative of the Consultant under penalty of perjury attesting that the Consultant does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.

**SECTION 5.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.

**IN WITNESS WHEREOF**, the Parties have caused this Amendment to be executed by its duly authorized representatives, effective as of the last date below.
