FIRST AMENDMENT TO CONTRACT FOR ASPHALT AND STRIPING SERVICES

WHEREAS, the County consents to and recognizes the Vendor's use of a fictitious name as set forth herein..

- **NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:
- **SECTION 1.** The above recitals are true and correct and are incorporated herein, in their entirety, by this reference.
- **SECTION 2.** Upon execution of this Amendment, and in accordance with Section 787.06, Florida Statutes, the Vendor shall provide the County with an affidavit, on a form approved by the County, signed by an officer or representative of the Vendor under penalty of perjury attesting that the Vendor does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.
- **SECTION 3.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
