## ORDINANCE NO. 85- 17

ORDINANCE AMENDING ORDINANCE NUMBER 81-26 AN SETTING FORTH RULES AND REGULATIONS TO IMPROVE PUBLIC SAFE'Y BY PROMOTING THE CONTROLS OF FIRE HAZARDS; REGULATING THE INSTALLATION, USE AND MAINTENANCE OF EQUIPMENT; REGULATING THE USE OF STRUCTURES, PREMISES AND OPEN AREAS IN THEUNINCORPORATED AREAS OF NASSAU COUNTY; PROVIDING FOR THE ABATEMENT OF FIRE HAZARDS; ESTABLISHING THE RESPONSIBILITIES AND PROCEDURES FOR ENFORCEMENT; SETTING FORTH STANDARDS FOR COMPLIANCE; PROVIDING PENALTIES FOR THE VIOLATION THEREOF, BY ADOPTING THE STANDARD FIRE PREVENTION CODE, MORE PARTICULARLY THE 1984 EDITION; FIXING PENALTIES FOR VIOLATION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, in order to secure the beneficial interest and purposes of public safety, health and general welfare through promoting controls of fire hazards in regulating the installation, use and maintenance of equipment and providing for the abatement of fire hazards, it is necessary to adopt a Nassau County fire code and to amend Ordinance number 81-26, and

WHEREAS, the Southern Standard Fire Prevention Code, 1984 edition, contains procedures for the above and sets forth standards, and

WHEREAS, the Board of County Commissioners deems it appropriate to adopt the 1984 Southern Standard Fire Prevention Code, and

NOW THEREFORE, BE IT ENACTED that Ordinance 85- be adopted as follows:

SECTION 1. SOUTHERN STANDARD CODE: The southern Standard Fire Prevention Code, being particularly the 1976 1984 edition thereof and the whole thereof, of which not less than three (3) copies have been and are now filed in the office of the Clerk of the County of Nassau and the same are hereby adopted and incorporated 482

as fully as if set forth at length herein, and from the date on which this ordinance shall take effect, the provisions therein shall be controlling.

SECTION 2. INVALIDITY: The invalidity of any section or provision of this Ordinance or of the code hereby adopted shall not invalidate other sections or provisions thereof.

SECTION 3. PENALTY: Any person who shall be found to be guilty of a violation of this ordinance shall be guilty of a misdemeanor, and upon conviction, shall be fined not more than \$500.00 and/or imprisoned for a term not to exceed ninety (90) days. Each separate day that a violation exists or continued shall be deemed a separate offense for the purpose of this ordinance.

SECTION 4. EFFECTIVE DATE: This ordinance shall be effective upon becoming law.
