ORDINANCE 2010 – 05

AN ORDINANCE OF NASSAU COUNTY, FLORIDA, AMENDING ORDINANCE NO. 87-38, AS AMENDED BY **ORDINANCE NO. 2001-13. TO ELIMINATE DISCRIMINATION** HOUSING: SPECIFICALLY AMENDING IN SECTION Ι. DECLARATION OF POLICY; SECTION IV, DISCRIMINATION IN THE SALE OR RENTAL OF HOUSING: SECTION V. DISCRIMINATION IN THE FINANCING OF HOUSING: AND SECTION VI. DISCRIMINATION IN THE PROVISION OF BROKERAGE SERVICE; ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the Nassau County Board of County Commissioners adopted

Ordinance No. 2001-13 which set forth a policy to eliminate discrimination in housing; and

WHEREAS, the Board desires to amend the Ordinance for clarification and

expansion of the policy;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY

COMMISSIONERS OF NASSAU COUNTY, FLORIDA:

1. SECTION I – DECLARATION OF POLICY

It is hereby declared to be the policy of Nassau County, Florida, in the exercise of its police power for public safety, public health, and general welfare, to assure equal opportunity to obtain adequate housing by all persons regardless of race, color, religion, ancestry, sex, <u>marital status</u>, familial status, <u>place of birth</u>, <u>age</u>, handicap, or national origin.

2. SECTION IV - DISCRIMINATION IN THE SALE OR RENTAL OF HOUSING

As made applicable by Section 3 and except as exempted by Section 3(A) and 7, it shall be unlawful:

A. To refuse to sell or rent after making of a bona fide offer, or to refuse to negotiate for the sale or rental of, or otherwise make unavailable or deny a dwelling to any person because of race, color, religion, ancestry, sex, <u>marital status</u>, familial status, place of birth, <u>age</u>, handicap, or national origin.

B. To discriminate against any person in the terms, conditions, or privileges of sale or rental of a dwelling, or in provision of services or facilities in connection therewith, because of race, color, religion, ancestry, sex, <u>marital status</u>, familial status, place of birth, <u>age</u>, handicap, or national origin.

C. To make, print, or public, or cause to be made, printed, or published, any notice, statement, or advertisement, with respect to the sale or rental of a dwelling that indicates any preference, limitations, or discrimination based on race, color, religion, ancestry, sex, <u>marital status</u>, familial status, place of birth, <u>age</u>, handicap, or national origin.

D. To represent to any person because of race, color, religion, <u>ancestry</u>, sex, <u>marital status</u>, <u>familial status</u>, <u>age</u>, <u>handicap</u>, or national origin that any dwelling is not available for inspection, sale, or rental when such dwelling is in fact so available.

E. For profit, to induce or attempt to induce any person to sell or rent any dwelling by representatives regarding the entry or prospective entry into the neighborhood

of a person or persons of a particular race, color, religion, ancestry, sex, <u>marital status</u>, familial status, place of birth, <u>age</u>, handicap, or national origin.

3. SECTION V -- DISCRIMINATION IN THE FINANCING OF HOUSING

It shall be unlawful for any bank, building and loan association, insurance company or other corporation, association, firm or enterprise whose business consists in whole or in part in the making of commercial real estate loans, to deny a loan or other financial assistance to a person applying therefore for the purpose of purchasing, constructing, improving, repairing, or maintaining a dwelling, or to discriminate against him in the fixing of the amount, interest rate, duration, or other terms or conditions of such loan or other financial assistance, because of the race, color, religion, ancestry, sex, <u>marital status</u>, familial status, place of birth, <u>age</u>, handicap, or national origin of such person or of any person associated with him in connection with such loans or other financial assistance, or of the present or prospective owners, lessees, tenants, or occupants of the dwelling or dwellings in relation to which such loan or other financial assistance is to be made or given: provided, that nothing contained in this Section shall impair the scope or effectiveness of the expectations, contained in Section 3.

4. SECTION VI – DISCRIMINATION IN THE PROVISION OF BROKERAGE SERVICE

It shall be unlawful to deny any person access to or membership or participation in any multi-listing service, real estate brokers organization or other services, organizations, or facility relating to the business of selling or renting dwellings, or to discriminate against him in the terms or conditions of such access, membership or participation on account of race, color, religion, ancestry, sex, marital_status, familial status, place of birth, age, handicap, or national origin.

5. Effective Date. This Ordinance shall become effective upon filing with the

Department of State.
