ORDINANCE 2023 - 006

AN ORDINANCE OF NASSAU COUNTY, FLORIDA AMENDING THE FUTURE LAND USE MAP OF THE COMPREHENSIVE PLAN; PROVIDING FOR THE RECLASSIFICATION OF APPROXIMATELY 0.42 ACRES OF REAL PROPERTY LOCATED ON THE NORTH SIDE OF LEWIS STREET, BETWEEN OCEAN BOULEVARD AND GREGG STREET, FROM HIGH DENSITY RESIDENTIAL (HDR) TO COMMERCIAL (COM); PROVIDING FOR FINDINGS: AND **PROVIDING AN EFFECTIVE DATE.**

WHEREAS, Jeanette Elizabeth Mobley Revocable Living Trust and Otis C Mobley Jr. are the owners of three parcels comprising 0.42 acres identified as Tax Parcel No. 00-00-30-010A-0003-0180, 00-00-30-010A-0003-0181 and 00-00-30-010A-0003-0182 by virtue of Deed recorded at O.R. 2315, page 945; O.R. 2126, page 1479; and O.R. 2497, page 1482 of the Public Records of Nassau County, Florida; and

WHEREAS, Jeanette Elizabeth Mobley Revocable Living Trust and Otis C Mobley Jr. have authorized the Nassau County Planning Department to file Application CPA22-011 to change the Future Land Use Map classification of the land described herein; and

WHEREAS, Jeanette Elizabeth Mobley Revocable Living Trust and Otis C Mobley Jr. have not been granted a change of Future Land Use Map designation on the subject property within the previous 12 months; and

WHEREAS, the Planning and Zoning Board, after due public notice conducted a public hearing on December 6, 2022 and voted to recommend approval of CPA22-011 to the Commission; and

WHEREAS, taking into consideration the above recommendations, the Commission finds that the reclassification is consistent with the 2030 Comprehensive Plan and the orderly development of Nassau County; and

WHEREAS, the Board of County Commissioners held a public hearing on January 23, 2023; and

WHEREAS, public notice of all hearings has been provided in accordance with Chapters 125 Florida Statutes and the Nassau County Land Development Code.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA:

<u>SECTION 1</u>. FINDINGS.

The FLUM amendment complies with the Goals, Objectives and Policies of the 2030 Comprehensive Plan, in particular Policy FL.01.04.

SECTION 2. PROPERTY RECLASSIFIED.

The real property described in Section 3 is reclassified from High Density Residential (HDR) to Commercial (COM) on the Future Land Use Map of Nassau County. The Planning Department is hereby authorized to amend the Future Land Use Map to reflect this reclassification upon the effective date of this Ordinance.

SECTION 3. OWNER AND DESCRIPTION.

The land reclassified by this Ordinance is owned by Jeanette Elizabeth Mobley Revocable Living Trust and Otis C Mobley Jr. and is identified by the following tax identification numbers, graphic illustration, and legal descriptions:

THE SOUTHERLY TWENTY-FIVE (25.0) FEET OF THE EASTERLY SEVENTY-FIVE (75.0) FEET OF LOT EIGHTEEN (18), BLOCK THREE (3), OF THE AMERICAN BEACH SUBDIVISION, A SUBDIVISION ACCORDING TO PLAT THEREOF RECORDED IN PLAT BOOK 2, PAGE 42, OF THE PUBLIC RECORDS OF NASSAU COUNTY, FLORIDA.
