

ORDINANCE NO. 2023-016

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, AMENDING ARTICLE VI SMALL COUNTY SURTAX, DIVISION 3, OPERATIONAL EXPENSES FOR INFRASTRUCTURE; SPECIFICALLY AMENDING SECTION 30-126, PURPOSE; STRIKING SECTION 30-128, RESOLUTION REQUIRED TO FUND PROJECT, REMOVING ANNUAL RESOLUTION REQUIREMENTS; PROVIDING FOR CODIFICATION; PROVIDING FOR CONFLICTING PROVISIONS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Nassau County, pursuant to Florida Statutes §212.055(3) adopted the Small County Surtax in Ordinance No. 1995-31; and

WHEREAS, The Board of County Commissioners finds that it is in the best interests of the citizens of Nassau County to further amend Ordinance No. 2001-38, which amended Ordinance No. 1995-31, as amended; and

WHEREAS, surtax revenue is expended in line with the Capital Improvement Plan and county budget, as approved by the Board of County Commissioners; and

WHEREAS, to provide a more efficient and effective government, individuals will be directed to the adopting resolutions for the Capital Improvement Plan and county operating budget.

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Nassau County, Florida:

SECTION 1. AMENDING SECTION 30-126, PURPOSE.

Section 30-126 of the Nassau County Code of Ordinances shall be amended to hereafter read as follows:

Section 30-126. - Purpose.

The purpose of this division is to levy a one cent (\$0.01) sales tax on all transactions occurring in the county that are subject to state tax imposed on sales, use, services, rentals, admissions and other transactions pursuant to F.S. §212.054. The revenues generated by said levy, ~~including all interest earned~~, shall be utilized for:

- (1) Operational expenses of any infrastructure and for any other purpose, excluding debt, ~~pursuant to a resolution of the board of county commissioners, which shall be considered annually as an agenda item at a regularly scheduled board meeting.~~

SECTION 2. AMENDING SECTION 30-128, RESOLUTION REQUIRED TO FUND PROJECT.

Section 30-128 of the Nassau County Code of Ordinances shall be amended to hereafter read as follows:

~~Section 30-128. – Resolution required to fund project.~~

~~The utilization of the proceeds from the collection of the surtax, including interest, shall be pursuant to a resolution of the board of county commissioners, which shall be considered annually as an agenda item at a regularly scheduled board meeting.~~

SECTION 3. CODIFICATION.

It is the intent of the Board of County Commissioners for Nassau County that the provisions of this Ordinance shall become and shall be made part of the Code of Ordinances of Nassau County, Florida. The sections of this Ordinance may be re-numbers or re-lettered and the words may be changed to section, article or other such appropriate word or phrase in order to accomplish such intention. The Nassau County Clerk of Courts will ensure that this Ordinance is codified into, and published, as part of the Nassau County Code of Ordinances.

SECTION 4. CONFLICTING PROVISIONS.

All ordinances, or parts of ordinances, in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

SECTION 5. SEVERABILITY.

It is the intent of the Board of County Commissioners of Nassau County, Florida, and is hereby provided, that if any section, subsection, sentence, clause, phrase, or provision of this Ordinance is held to be invalid or unconstitutional by any court of competent jurisdiction, such invalidity or unconstitutionality shall not be so construed as to render invalid or unconstitutional the remaining provisions of this Ordinance.

SECTION 6. EFFECTIVE DATE.

This Ordinance shall take effect upon filing with the Secretary of State as provided in Florida Statutes, Section 125.66.




