#### **RESOLUTION NO. 2001-**<u>106</u>

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, **RELATING TO THE CONSTRUCTION AND FUNDING OF** ROAD IMPROVEMENTS; CREATING THE PIRATES WOOD ASSESSMENT AREA; CONFIRMING THE INITIAL ASSESSMENT **RESOLUTION; ESTABLISHING** THE MAXIMUM AMOUNT OF THE ANNUAL ASSESSMENT FOR EACH PARCEL UNIT; IMPOSING ASSESSMENTS AGAINST PROPERTY WITHIN THE PIRATES WOOD ASSESSMENT AREA; APPROVING THE ASSESSMENT ROLL: PROVIDING FOR COLLECTION OF THE ASSESSMENTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners (the "Board") of Nassau County, Florida, enacted Ordinance No. 2000-37 (the "Ordinance"), to provide for the creation of Assessment Areas (as described thereunder) and authorize the imposition of special assessments to fund the construction of local improvements to serve the property located therein; and

WHEREAS, on May 14, 2001, the Board adopted Resolution No. 2001-74, the Initial Assessment Resolution, proposing creation of the Pirates Wood Assessment Area and describing the method of assessing the cost of Road Improvements (as therein defined) against the real property that will be specially benefitted thereby, and directing preparation of the tentative Assessment Roll and provision of the notices required by the Ordinance; and

WHEREAS, pursuant to the provisions of the Ordinance, the County is required to confirm or repeal the Initial Assessment Resolution, with such amendments as the Board deems appropriate, after hearing comments and receiving objections of all interested parties; and

WHEREAS, the Assessment Roll has heretofore been filed with the office of the County Coordinator, as required by the Initial Assessment Resolution and the Ordinance; and

WHEREAS, as required by the terms of the Initial Assessment Resolution and the Ordinance, notice of a public hearing has been published and mailed to each property owner proposed to be assessed notifying such property owner of the opportunity to be heard; the proof of publication and an affidavit of mailing are attached hereto as Appendices A and B respectively; and

WHEREAS, in order to allow additional time to obtain more favorable financial terms, on June 18, 2001 the Board continued a hearing to, and on July 16, 2001 a public hearing was held and comments and objections of all interested persons were heard and considered as required by the terms of the Ordinance.

### NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, AS FOLLOWS:

**SECTION 1. AUTHORITY.** This Resolution is adopted pursuant to the Ordinance, Chapter 125, Florida Statutes, and other applicable provisions of law.

**SECTION 2. DEFINITIONS.** This Resolution is the Final Assessment Resolution as defined in the Ordinance. All capitalized terms in this Resolution shall have the meanings defined in the Ordinance and the Initial Assessment Resolution.

#### \* SECTION 3. CREATION OF PIRATES WOOD ASSESSMENT AREA.

The Pirates Wood Assessment Area is hereby created to include: The Pirate's Wood Subdivision, being a portion of Section 43, Township 3 North, Range 28 East, Nassau County, Florida. The Assessment Area is created for the purpose of improving the use and enjoyment of property located therein by funding the construction of Road Improvements to benefit property located within the Assessment Area.

SECTION 4. CONFIRMATION OF INITIAL ASSESSMENT RESOLUTION. The Initial Assessment Resolution is hereby confirmed.

**SECTION 5. APPROVAL OF ASSESSMENT ROLL.** The Assessment Roll, a copy of which is attached hereto as Appendix E, is hereby approved.

#### SECTION 6. ASSESSMENTS.

(A) The Tax Parcels described in the Assessment Roll are hereby found to be specially benefitted by construction of the Road Improvements in the amount of the maximum annual Assessment set forth in the Assessment Roll. The methodology for computing annual Assessments described in the Initial Assessment Resolution is hereby approved. Annual Assessments computed in the manner described in the Initial Assessment Resolution are hereby levied and imposed on all Tax Parcels described in the Assessment Roll at a maximum annual rate of \$410 per Parcel Unit for a period of 13 years, commencing with the ad valorem tax bill to be mailed in November 2001.

(B) Upon adoption of the Annual Assessment Resolution for each Fiscal Year, the Assessments shall constitute a lien against assessed property equal in rank and dignity with the liens of all state, county, district or municipal taxes and other non-ad valorem assessments. Except as otherwise provided by law, such lien shall be superior in dignity to all other liens, titles and claims, until paid. The lien shall be deemed perfected upon adoption by the Board of the Annual Assessment Resolution and shall attach to the property included on the Assessment Roll as of the prior January 1, the lien date for ad valorem taxes.

**SECTION 7.COLLECTION OF ASSESSMENTS.** The Assessments shall be collected pursuant to the Uniform Assessment Collection Act. Upon adoption of the Annual Assessment Resolution for each Fiscal Year, the County Coordinator shall cause the certification and delivery of the Assessment Roll to the Tax Collector by September 15, in the manner prescribed by the Uniform Assessment Collection Act. The Assessment Roll, as delivered to the Tax Collector, shall be accompanied by a Certificate of Non-Ad Valorem Assessment Roll in substantially the form attached hereto as Appendix F.

SECTION 8.EFFECT OF FINAL ASSESSMENT RESOLUTION. The adoption of this Final Assessment Resolution shall be the final adjudication of the issues presented herein and in the Initial Assessment Resolution (including, but not limited to, the method by which the Assessments will be computed, the Assessment Roll, the maximum annual Assessment, the levy and lien of the Assessments and the terms for prepayment of the Assessments) unless proper steps are initiated in a court of competent jurisdiction to secure relief within twenty days from the date of Board action on this Final Assessment Resolution.

**SECTION 9. PREPAYMENT NOTICE.** The County Coordinator is hereby directed to provide notice by first class mail to the owner of each Tax Parcel described in the Assessment Roll of the opportunity to prepay all future annual Assessments, without financing cost. The notice, in substantially the form attached as Appendix C, shall be mailed to each property owner at the address utilized for the notice provided pursuant to Section 2.05 of the Initial Assessment Resolution.

**SECTION 10. ASSESSMENT NOTICE.** The County Coordinator is hereby directed to record a general notice of the Assessments in the Official Records Book in the office of the Nassau County Clerk of Courts. Such notice shall be in substantially the form attached as Appendix D. The preliminary Assessment Roll and each annual Assessment Roll shall be retained by the County Coordinator and shall be available for public inspection.

EFFECTIVE DATE. This Resolution shall take effect **SECTION 11.** immediately upon its adoption.
