ORDINANCE NO. 87-32

AN ORDINANCE AMENDING ORDINANCE 74-34, INCREASING THE FEES IN SECTION 6-18 TO CONFORM WITH THE FEES PURSUANT TO FLORIDA STATUTES CHAPTER 588.18; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners has been made aware of the need to increase the fees for the impoundment of animals, pursuant to Ordinance 74-34, and

WHEREAS, the State of Florida has enacted Florida Statutes
Chapter 588 which deals with fencing and livestock at large;

NOW THEREFORE BE IT ORDAINED this 2/5 day of April, 1987 that Ordinance 74-34 is hereby Amended as follows:

Section 6-18. Same - Impounding; fees.

- (1) Any person may, and it shall be the duty of the Sheriff of Nassau County, Florida, and his deputies, and--of--every constable and/or the County Animal Control Officer, to take up and impound, or to cause to be taken up and impounded, any livestock found running or roaming at large within the boundaries of Nassau County, Florida.
- (2) As and for compensation for the taking up and impounding of livestock found running or roaming at large within the boundaries of Nassau County, Florida, the person or officer so taking up and impounding the same, and the person or officer keeping it shall be entitled to and shall receive the following sums:
- (a)---Fifty--cents--(\$0.50)--for--each--animal--taken--up--and impounded;
 -----(b)--Fifty--cents--(\$0.50)--per-day--for--the-keep--and--care--of each-horse;-ass;-mule-and-bovine-animal;
 -----(c)--Twenty-five-cents-(\$0.25)--per-day--for--the-keep--and--care of--each--hog;--sheep;--goat--and--other--animal;--and--the--person--having

charge-of-the-impounded-animal-shall-feed-and-water-it-not-less
than-twice-per-day-(Ch-277627-Sub-Section-37-Sp:-Acts-1951)

- 1. For impounding each animal, the sum of \$20 and mileage incurred, at the rate of 20 cents per mile.
- 2. For serving any notice and making return thereon, the sum of \$10 and mileage incurred, at the rate of 20 cents per mile.
- 3. For feed and care of impounded animals, the sum of \$5 per day per animal.
- 4. For advertising or posting notices of sale of impounded animals, the same as provided by law for advertising property for sale under process.
- 5. For sale or other dispositions of impounded animals, the sum of five dollars (\$5.00).
- 6. For report of sale of impounded animals, the sum of two dollars, fifty cents (\$2.50).

Section 6-30, Florida Statutes 588.

The provisions of Florida Statutes Chapter 588, if in conflict, shall apply in each such case as if the provisions of said statute were inserted in full in Ordinance 74-34. If any portion of Ordinance 74-34 is found unconstitutional or in any way inoperative, within the provisions of Florida Statutes Chapter 588 shall be in full force and effect in the County.

Section 6-31, Effective Date.

This Ordinance shall take effect as provided by general law.
