ORDINANCE NO. 88 - 11

AN ORDINANCE AMENDING ORDINANCE 86-1, WHICH PROVIDES FOR THE REGISTRATION, EXAMINATION, AND CERTIFICATION OF CONTRACTORS, THE RENEWAL THEREOF, AND MAKING CERTAIN EXCEPTIONS AND EXEMPTION; PRESCRIBING DUTIES AND POWERS OF THE CONTRACTORS REVIEW BOARD; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners has determined that the Contractors' Review Board Ordinance No. 86-1 should be amended; and

WHEREAS, the Board of County Commissioners has determined that the current expiration of and subsequent renewal of licenses conflicts with the expiration of and subsequent renewal of Occupational Licenses; and

WHEREAS, the Board of County Commissioners desires to set new expiration dates and provide for grace periods to those new expiration dates.

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Nassau County, Florida, on the 19th day of January , 1988, that Ordinance 86-1 is hereby amended as follows:

SECTION IX. License Expiration

All-licenses-shall-expire-on,-and-shall-be-null-and-void after--September--30th--of--each--year,--and--no--construction, maintenance,-or-Repair-work-shall-be-done-by,-and-no-permits shall-be-issued-to-any-General-Contractor,-Class-"A",-Building Contractor,-Class-"B",-Residential-Contractor,-Class-"C",-Master Electrician,-Master-Plumber,--Master-Hearing,--Air-Conditioning, Refrigeration--Contractor,--Swimming--Pool--Contractor,--Roofing Contractor,-and-Special-Trades-contractor-who-has-no-such-valid certification-as-herein-provided.

A. All Journeyman Electrician, Journeyman Plumber,

Journeyman Heating, Air-Conditioning and Refrigeration, and

Journeyman Sheet Metal licenses shall expire on September 30th of each year.

- B. All General Contractor, Class "A", Building Contractor, Class "B", Residential Contractor, Class "C", Roofing Contractor, Masonry Contractor, Swimming Pool Contractor, Solar Water Heating Contractor, Limited Mechanical Contractor, and Specialty Contractor licenses shall expire on January 30th of each year, and no construction, maintenance, or repair work shall be done by, and no permit shall be issued to, any aforementioned contractor who has no such valid certification as herein provided.
- C. All General Contractor, Class "A", Building Contractor, Class "B", Residential Contractor, Class "C", Roofing Contractor, Masonry Contractor, Swimming Pool Contractor, Solar Water Heating Contractor, Limited Mechanical Contractor, and Specialty Contractor holding a current license as of the date of this Ordinance shall be forthwith granted a grace period of four (4) months from September 30, 1988, to January 30, 1989, at which time all aforesaid licenses will expire and will continue to expire each year thereafter.
- D. All Master Electrician, Master Plumber, Master Heating,
 Air-Conditioning, and Refrigeration, Classes "A", "B", and "C",
 Master Sheet Metal, and Mechanical Contractor licenses shall
 expire on June 30th of each year, and no construction,
 maintenance, or repair work shall be done by, and no permits
 shall be issued to, any aforementioned contractor who has no such
 valid certification as herein provided.
- E. All Master Electrician, Master Plumber, Master Heating,
 Air-Conditioning, and Refrigeration, Classes "A", "B", and "C",

 Master Sheet Metal, and Mechanical Contractors holding a current

 license as of the date of this Ordinance shall be forthwith

granted a grace period of nine (9) months from September 30, 1988, to June 30, 1989, at which time all aforesaid licenses will expire and will continue to expire every year thereafter.

This Ordinance shall become effective upon signature pursuant to Law.
