WHEREAS, the Board of County Commissioners has been made aware by the Fire Safety Inspector of Fire Prevention that should be adopted in Nassau County; and

WHEREAS, the Board has reviewed said Code and Standards with

the Fire Safety Inspector at a workshop session and conducted a public hearing regarding said Codes and standards; and

WHEREAS, the Board finds it would be in the best interest of the citizens of Nassau County to adopt said Codes and Standards.

NOW, THEREFORE, BE IT ORDAINED this 24th day of January, 1994, by the Board of County Commissioners of Nassau County, Florida, that Ordinance 81-26, as amended, be further amended as follows:

1. **SECTION 1. STANDARD FIRE PREVENTION CODE:** The Standard Fire Prevention Code, as adopted by the Southern Building Code Congress International, being particularly the ~~current~~ 1991 thereof and the whole thereof, and the same is hereby adopted and incorporated as fully as if set forth at length herein, and from the date on which this ordinance shall take effect, the provisions therein shall be controlling.

2. **SECTION 2. NATIONAL FIRE PROTECTION CODE:** The National Fire Protection Association (NFPA) 101, Life Safety Code, ~~1985~~ 1991 Edition, except as superseded by Florida Administrative Code, Section 4-A and Section 633, Florida Statutes, is hereby adopted.

3. **SECTION 3. 
roadway by which it is accessed. Hydrant(s) shall be positioned not more than five (5) feet away from the curb or berm of the roadway.

III. PENALTY. Any person violating any provision of this ordinance shall be deemed guilty of a misdemeanor of the second degree and upon conviction thereof shall be subject to a fine of up to \$500.00 and/or ten (10) days in the Nassau County Detention Facility. If such violation is continued, each day's violation shall be a separate offense.

IV. APPEAL. The decision of the spacing of fire hydrants may be appealed to the Board of County Commissioners with thirty (30) days of the Public Safety Director or his designee determining the spacing requirements. The Board should schedule the appeal at its next regularly scheduled meeting upon receipt of the appeal.

V. EFFECTIVE DATE. This ordinance shall become effective upon its being filed in the office of the Secretary of State


