RESOLUTION AMENDING AND INCREASING BUDGET OF NASSAU COUNTY, FLORIDA, FOR THE FISCAL YEAR ENDING SEPTEMBER 30th., 1962.

WHEREAS, the Budget for Nassau County for the Fiscal Year ending September 30th., 1962, as adopted on August 7th., 1961, shows the anticipated balances to be brought forward-Cash as \$92,000.00 in the Fine & Forfeiture Fund and \$26,000.00 in the Road & Bridge Fund, and

WHEREAS, the actual Cash balance brought forward October 1st., 1961 in the Fine & Forfeiture Fund was \$122,225.07 and the actual Cash balance brought forward in the Road and Bridge Fund was \$40,627.12 thereby creating an excess above the balances anticipated of \$30,225.07 in the Fine & Forfeiture Fund and \$14,627.12 in the Road & Bridge Fund, and

WHEREAS, this Board has been informed that certain Federal and/or State Funds will be available for Civil Defense purposes, provided same are matched by County funds, and

WHEREAS, this Board has determined, after careful and due consideration, that it is to the best interest and welfare of the citizens of Nassau County, Florida, that the appropriations for Civil Defense and certain appropriations in the Road & Bridge Fund be increased and that appropriation be made for the construction of a Nassau County Emergency Operations Center, so as to provide facilities for the operation of County Government in case of nucelar attack,

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Nassau County, Florida, in regular session duly assembled on this the 15th., day of November, 1961, that the Budget for Nassau County, Florida, for the Fiscal year ending September 30th., 1962, be amended as follows:
