

RESOLUTION 90 - 95

A RESOLUTION ADDING THE NAME OF "POGY PLACE" PURSUANT TO ORDINANCE 87-19, SECTION IV, PARAGRAPH D(1); SETTING FORTH SIGN LOCATIONS; PROVIDING AN EFFECTIVE DATE:

WHEREAS, the Department of Emergency Services has requested the addition of the name of the road which is now unnamed to the name of "POGY PLACE" due to a conflict in the 911 address grid; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, believes that this addition will be beneficial for the citizens of Nassau County.

NOW, THEREFORE, BE IT RESOLVED this 14th day of May, 1990, by the Board of County Commissioners of Nassau County, Florida, as follows:

- 1. Pursuant to Ordinance 87-18, Section IV, Paragraph D(1), the unnamed road shall be named "POGY PLACE".
- 2. Signs shall be erected by the County to show the name of the road as shown on the map attached hereto and made a part hereof.



ENTRANCE




