

RESOLUTION 93 - 76

A RESOLUTION TO CHANGE THE FOLLOWING
STREET NAMES IN THE ONEIL AREA

WHEREAS, the Board of County Commissioners of Nassau County, Florida, believe that the following changes are beneficial for the health, safety, and welfare of the citizens of Nassau County; and

WHEREAS, the following changes will help establish a consistent street naming and addressing grid for all emergency systems as is intended by the Nassau County Board of County Commissioners as stated in Ordinance 87-18 and Ordinance 88-23; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "HOLLY POINT DRIVE EAST"; located in the Holly Point Subdivision in Section 36,45; Township 2N; range 28E; to the name of "HOLLY POINT ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "HOLLY POINT SOUTH"; located in the Holly Point Subdivision in Section 36,45; Township 2N; Range 28E; to the name of "WINTERBERRY AVENUE "; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the unnamed easement off Barnwell Road known as "HEATH POINT LANE"; to the name of "SEVILLE AVENUE"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "KAREN LANE"; located in the Oak Hill Estates Subdivision in Section 31; Township 2N; Range 28E; to the name of "KAREN WALK"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road which extends from Karen Lane and is named "LEO DRIVE"; located in the Oak Hill Estates subdivision in Section 31; Township 2N; Range 28E; to the name of "KAREN WALK"; due to conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested than an unnamed easement running east off of S. R. 107 in the Nassauville area located in Section 34,44-45; Township 2N; Range 28E; be named "GOFFINSVILLE ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "DUCK LAKE DRIVE SOUTH"; in the Holly Point Subdivision located in Section 36, 45: Township 2N; Range 28E; to the name of "DUCK LAKE DRIVE WEST"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "CREWS ROAD SOUTH"; located in Section 35, 45; Township 2N; Range 28E; to the name of "LONNIE CREWS ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "CREWS ROAD"; located in Section 35, 45; Township 2N; range 28E; to the name of "CREWS ROAD NORTH"; for clarification in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested that the correct spelling for "OELSNOR/OELSNER DRIVE"; located in Seymore Point Subdivision; located in Section 44, 45; Township 2N, Range 28E; be defined as "OELSNER"; for clarification in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "DIRT ROAD"; located in Section 32-33; 43; Township 2N; Range 28E; to the name of "DIRT ROAD"; for clarification in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested that an unnamed easement extending off of Hendrick Road; located in Section

32,33,43; Township 2N; Range 28E; be named "ORIOLE STREET"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested that an unnamed easement extending off of Hendricks Road; located in Section 32,33,43; Township 2N; Range 28E; be named "HATTON ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested that an unnamed easement extending off of Hendricks Road; located in Section 32,33,43; Township 2N; Range 28E; be named "LOUSHEL TONY ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested that an unnamed easement extending off of Hatton Road; located in Section 32,33,43; Township 2N; Range 28E; be named "BIMINI AVENUE"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested that an unnamed road which runs in a NS direction extending Steven Raod in the Nassauville area; located in Section 31, Township 2N; Range 28E; be named "STEVEN ROAD"; to allow addressing on the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested that an unnamed easement which runs in an EW direction off of Blackrock Road; located in Section 24,39; Township 2N, Range 28E; be named "ONYX WAY"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested that the proper spelling for "SEYMOURE/SEYMORE POINT ROAD"; located in Section 44,54; Township 2N; Range 28E; be defined as "SEYMORE POINT ROAD"; for clarification in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change in the road running in a NS direction off of Tyson Road named "RAINBOW ROAD"; located in Section 32,33,43; Township 2N; Range 28E; to the name of "RAINBOW ACRES ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change in the portion of Tyson Road which extends in a NS direction and is known as "TYSON ROAD AND ALLIGATOR CREEK ROAD"; located in Section 33,43; Township 2N; Range 28E; to the name of "ALLIGATOR CREEK ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change in the road named "LINDA HALL ROAD NORTH/SCHUBERT"; located in Section ; Township ; Range ; to the name "LINDA HALL ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested that the change in the road "THE PORTION OF WILDER BOULEVARD WHICH RUNS IN AN NS DIRECTION OFF OF NASSAUVILLE or JIM BENNET ROAD"; located in Section 34,44-45; Township 2N; Range 28E; to the name of "WILDER STREET"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change in the road named "R/W "A"; located in Section 34, Township 2N; Range 28E; to the name "ALLIGATOR CREEK ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change in the road named "3RD MOUNT ZION, WHICH RUNS IN A NS DIRECTION"; in the G. A. Prince Subdivision; located in Section 24,39; Township 2N; Range 28E; to the name "AUGUSTA SAVAGE STREET"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change in the road named "3RD MOUNT ZION, WHICH RUNS IN A EW DIRECTION"; in the G. A. Prince Subdivision; located in Section 24,38; Township 2N; Range 28E; to the name "CAVALIER AVENUE"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested that the unnamed easement extending between Wilder Boulevard and Nassauville Road; in the Ellis Landing Subdivision; located in Section 34,44-45; Township 2N; Range 28E; be named "PANTHER WAY"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested that an unnamed easement extending off of S.R. 200 running in a NS direction, location in Section S1/2 of 25; Township 2N; Range 28E; be named "ARCHER ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change in the roads named "OLD FERNANDINA HIGHWAY, PINE GROVE ROAD, and OLD SHELL ROAD"; located in Section 26,27,28; Township 2N; Range 28E and Section 38,40-41,48; Township 2N; Range 28E; to the name of "PINE GROVE ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change in the portion which runs in an EW direction of the road named "PINE GROVE ROAD"; located in Section 26,27,28; Township 2N; Range 28E and Section 38-40-41,48; Township 2N; Range 28E; be named "OLD CHURCH ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "SCOTT ROAD"; located in Section 26,27; Township 2N; Range 28E; to the name "ONEIL-SCOTT ROAD"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the unnamed easement which extends EW off of NELSON ROAD; located in Section 38,40-41, 48; Township 2N; Range 28E; be named "STAGHORN LANE"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the unnamed road which extends EW off of CLEMENTS ROAD; located in Section 38,40-41,48; Township 2N; Range 28E; be named "AUDUBON AVENUE"; due to a conflict in the 911 address grid; and{

WHEREAS, the Department of Emergency Services has requested the change in the road named "LITTLE BERRY LANE"; located in Section 40-41, Township 2N; Range 28E; be changed to "LITTLEBERRY LANE"; due to a conflict in the 911 address grid, and

WHEREAS, the Department of Emergency Services has requested the unnamed easement running EW on the south side of the SHAVE BRIDGE be named "WADE PLACE"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the unnamed easement running under the SHAVE BRIDGE be named "OTIS TRAIL"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change in the road named "HICKORY LANE"; in the Otter Run Subdivision; located in Section 38,40-41,48; Township 2N; Range 28E; to the name "HICKORY PLACE"; due to a conflict in the 911 address grid; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, believe that these changes will be beneficial for the citizens of Nassau County.

NOW, THEREFORE, BE IT RESOLVED that the above street names shall be changed and street signs shall be erected by the Road and Bridge Department to reflect these changes, and new name designations.
