**A RESOLUTION TO CHANGE THE FOLLOWING
STREET NAME IN THE CALLAHAN AREA**

WHEREAS, the Board of County Commissioners of Nassau County, Florida, believe that the following changes are beneficial for the health, safety, and welfare of the citizens of Nassau County; and

WHEREAS, the following changes will help establish a consistent street naming and addressing grid for all emergency systems as is intended by the Nassau County Board of County Commissioners as stated in Ordinance 87-18 and Ordinance 88-23; and

WHEREAS, citizens of Sections 36 and 25 of Township 2N, Range 24E, have petitioned the 9-1-1 Operations Office for change of street name; and

WHEREAS, the 911 Coordinator's Office has reviewed the requests in accordance with Ordinance Number 92-14; and

WHEREAS, the Nassau County Department of Public Safety has recommended that "the road currently known as Hathaway Drive which extends south off Country Road 108 until it reaches the east/west segment now known as Timiquan Avenue"; be named "Hathaway Drive"; and that "the portion which extends south from the intersection of Hathaway Drive and the east/west segment now known as Timiquan Avenue"; be named "Coquina Way"; to avoid a conflict in the 9-1-1 address grid; and


WHEREAS, the Nassau County Department of Public Safety has recommended that the unnamed easement which extends east and west off Hathaway Drive be named "Timiquan Avenue", to avoid a conflict in the 911 address grid; and

WHEREAS, the Nassau County Department of Public Safety has recommended that the unnamed easement which extends south at the western end of the unnamed easement which extends east and west off Hathaway Drive"; be named "CARLISLE PLACE"; to avoid a conflict in the 9-1-1 addressing grid; and


NOW, THEREFORE, BE IT RESOLVED, that the above street names shall be changed and street signs shall be erected by the Road and Bridge Department to reflect these changes, and new designations.

ADOPTED this 10th day of July, 1995, by the Board of County Commissioners of Nassau County, Florida, as follows:


