RESOLUTION NUMBER 95-14

WHEREAS, the 911 Coordinator's office has forwarded the request to the Board of County Commissioners for consideration; now

THEREFORE LET IT BE RESOLVED: THIS ^{28th} DAY OF ^{November}, 1994 that the street known us unnamed off <u>CRM21</u>, in Nassau County, Florida be hereafter referred to and known as Star Bright Place , and the County Engineer shall be authorized to erect any and all necessary signs indicting said name.
