

RESOLUTION 98-169

WHEREAS the Nassau County Impact Fee Ordinance Trust Fund has received impact fees pursuant to Ordinance 87-17 and Resolution 89-22. A 5% administrative fee is distributed to the Clerk of Courts and Building, Zoning, and Planning each. These impact fees are in excess of the amount budgeted in 1997/98.

WHEREAS these revenues were not anticipated in the 1997/98 budget year for the Impact Fee Ordinance Trust Fund.

BE IT THEREFORE resolved by the Board of County Commissioners, Nassau County, Florida in regular session, duly assembled on the 23rd day of November, 1998, the following budget amendment pursuant to Florida Statutes Chapter 129.06 (2) (d) be adopted:
