assistance to any employees who have come into the legal department, and served as a mentor offering freely of her time and expertise to assist them; and


WHEREAS, Ann R. Myers has announced her retirement; and

WHEREAS, Ann R. Myers will be deeply missed.


NOW, THEREFORE BE IT RESOLVED this 6th day of February, 2007 by the Board of County Commissioners of Nassau County, Florida that:

2. The Board extends their gratitude to Ann R. Myers for her service and dedication to Nassau County.






