#### **RESOLUTION NO. 2010-211**

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA APPROVING THE ISSUANCE BY THE COUNTY HOUSING **FINANCE** BREVARD AUTHORITY. INDIVIDUALLY, OR JOINTLY WITH ANOTHER FLORIDA HOUSING FINANCE AUTHORITY OR SOLELY BY SUCH OTHER FLORIDA HOUSING FINANCE AUTHORITY OF NOT TO EXCEED \$50,000,000 SINGLE FAMILY MORTGAGE REVENUE BONDS, TO BE ISSUED FOR THE PRINCIPAL PURPOSE OF FINANCING THE PURCHASE OF SINGLE-FAMILY, OWNER-OCCUPIED HOMES FOR PERSONS OF MIDDLE OR LESSER INCOME WITHIN THE MODERATE, AUTHORITY'S AREA OF **OPERATION, INCLUDING NASSAU** COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Nassau County, Florida (the "County") desires to participate in a single family bond program in calendar year 2010, such program not to exceed \$50,000,000 in aggregate principal amount of bonds, as a participant in a program in which bonds are issued by the Brevard County Housing Finance Authority (the "Brevard Authority") or another Florida Housing Finance Authority (a "Florida Authority") or in a joint issue with two Florida Authorities, to provide financing of qualified owner-occupied single family residences to alleviate the shortage of housing in various counties within the State of Florida, including Nassau County, Florida (the "County") for persons of moderate, middle or lesser incomes therein; and

WHEREAS, in order to satisfy the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended, the County held a public hearing on the proposed issuance of the bonds for the purposes herein stated on December 13, 2010, which date is more than 14 days following the first publication of notice of such public hearing in a newspaper of general circulation in Nassau County, Florida (a true and accurate copy of the proof of publication of such notice is attached hereto as Exhibit A), which public hearing was conducted in a manner that provided a reasonable opportunity for persons with differing views to be heard on both the issuance of such bonds and the location and nature of the items to be financed, refinanced or reimbursed with the proceeds therefrom.

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, as follows:

1. The issuance by the Brevard County Housing Finance Authority, individually, or jointly with another Florida Housing Finance Authority or solely by such other Florida Housing Finance Authority, of its Single Family Mortgage Revenue Bonds, in an aggregate principal amount not to exceed \$50,000,000 (the "Bonds"), in one or more series from time to time pursuant to a plan of finance, for the principal purpose of financing the purchase of single-family, owner-occupied homes for persons of moderate, middle or lesser income within the Authority's area of operation, including Nassau County, Florida, is hereby approved.

2. The form of notice of public hearing attached hereto as Exhibit B is hereby approved.

This resolution shall take effect immediately upon its adoption. 3.
