**WHEREAS**, Alyson Hall has exemplified an ethic of hard work, commitment, and academic excellence by earning this scholarship; and


**WHEREAS**, Alyson Hall has portrayed an attitude that positively promotes the ideals of learning and education; and


**WHEREAS**, all the citizens of Nassau County are proud of Alyson Hall for her accomplishment.


1. Alyson Hall is hereby honored and commended for earning the Congress Bundestag Youth Exchange Scholarship.






