WHEREAS, Barry V. Holloway served as the 2<sup>nd</sup> Vice President, the 1<sup>st</sup> Vice President and currently President Elect on the Florida Association of Counties Executive Committee; and


WHEREAS, Barry V. Holloway has always afforded every citizen who has appeared before the Board of County Commissioners respect and fairness; and


NOW, THEREFORE, BE IT RESOLVED this 10th day of November, 2014 by the Board of County Commissioners of Nassau County, Florida as follows:






