WHEREAS, the Northeast Florida Fair Association relies on County and State Capital Funding for making repairs to current facilities and for building new facilities; and

WHEREAS, the Nassau County Board of County Commissioners acknowledges the Northeast Florida Fair Association's benefit to the public and supports their efforts to make improvements to existing facilities at the fairgrounds.
