**WHEREAS**, the Town of Hilliard is desirous to transfer maintenance responsibility to Nassau County, and


**WHEREAS**, the Nassau County Board of County Commissioners is willing to accept this responsibility, and

**PASSED AND DULY ADOPTED** this 22<sup>nd</sup> day of February, 2016.



Dear Mr. Herring:

Thank you for your commitment to assume the maintenance responsibility of the traffic control devices on the State Highway System in the Town of Hilliard as provided in the attachment. In order to ensure Nassau County is assuming maintenance of satisfactory equipment, the Department intends on completing the following maintenance items for the CR 108 and SR 15 Traffic Control Signal by July 1, 2016.

1. Install upgraded grounding
2. Install new pedestrian signage and pedestrian pole board
3. Install a TrafficWare TS Type II cabinet
4. Install CCTV camera and wireless internet connection to the Verizon cellular. Nassau County will be responsible for the Verizon bill
5. Install FLIR video detection
6. Install new Street Name signs
