

RESOLUTION NO. 2016- 59

A RESOLUTION OF NASSAU COUNTY, FLORIDA APPROVING THE INTERLOCAL AGREEMENT THAT CONTINUES THE COUNTY AS A MEMBER OF THE FIRST COAST WORKFORCE DEVELOPMENT CONSORTIUM; AUTHORIZING THE CONSORTIUM TO ACT ON THE COUNTY'S BEHALF IN THE CONTINUATION OF AN AREA WORKFORCE DEVELOPMENT PLAN IN ACCORDANCE WITH THE INTERLOCAL AGREEMENT; AUTHORIZING EXECUTION OF THE INTERLOCAL AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT RESOLVED BY THE NASSAU COUNTY BOARD OF COUNTY COMMISSIONERS:

SECTION 1. AUTHORITY FOR THE RESOLUTION. This Resolution is adopted pursuant to the provisions of section 125.01 and Part I of Chapter 163, Florida Statutes.

SECTION 2. FINDINGS. Nassau County, Florida (the "County"), does hereby find and determine that:

(A) The County desires to be included in an area workforce development plan to avail it citizens of the benefits of the United States Workforce Innovation and Opportunities Act.

(B) The County desires to continue as a member of the First Coast Workforce Development Consortium.

(C) In order to properly memorialize the continuation of the County to membership in the First Coast Workforce Development Consortium, it is necessary and desirable for the County to authorize, execute, and deliver the Interlocal Agreement Continuing the First Coast Workforce Development Consortium (the "Interlocal Agreement"), the form of which is attached hereto as Exhibit A.

SECTION 3. THE APPROVAL OF THE INTERLOCAL AGREEMENT. The form, terms and provisions of the Interlocal Agreement, submitted to this meeting, attached hereto as Exhibit A is intended to set the terms and conditions for the First Coast Workforce Development Consortium to act on behalf of the County in the continuation of the multi-jurisdictional consortium. The form, terms and provisions of the Interlocal Agreement are hereby approved and the Chair of the Board of County Commissioners of the County and Clerk of the County are hereby authorized to execute and deliver said Interlocal Agreement in its name on behalf of the County.


SECTION 4. FILING OF INTERLOCAL AGREEMENT. The County Clerk is hereby directed to file the Interlocal Agreement with the Clerk of the Circuit Court in Clay County, Florida as required by Section 163.01(11), Florida Statutes.

SECTION 5. SEVERABILITY AND INVALID PROVISIONS. If any one or more of the covenants, agreements or provisions herein contained shall be held contrary to any express provision of law or contrary to the policy of express law, though not expressly prohibited or against public policy, or shall for any reason whatsoever be held invalid, then such covenants, agreements or provisions shall be null and void and shall be deemed separable from the remaining covenants, agreements or provisions and shall in no way affect the validity of any of the other provisions hereof or of the Interlocal Agreement.

SECTION 6. EFFECTIVE DATE. This Resolution shall become effective immediately upon its adoption.


