

RESOLUTION NO. 2019 - 24

A RESOLUTION RESCINDING RESOLUTION NO. 2009-169 AND RESOLUTION NO. 2010-141 AND ESTABLISHING LOAD LIMITS FOR CLASSIFICATIONS OF WASTE MATERIALS ACCEPTED AT THE NASSAU COUNTY CONVENIENCE RECYCLE CENTER

WHEREAS, Ordinance No. 91-17, as amended, provides for the imposition of fees for the various classifications of waste materials; and


WHEREAS, Ordinance No. 91-17, as amended, provides for fees to be established pursuant to a resolution adopted by the Board of County Commissioners.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Nassau County, Florida, as follows:


1. Only in-county residential waste delivered by Nassau County residents shall be accepted at the West Nassau Convenience Center. Residential construction and demolition debris will not be accepted.
2. The attached Exhibit A sets forth the classification of waste that will be accepted at the West Nassau Convenience Center and the fees for each of the classifications.
3. The fees set forth in the fee schedule, attached hereto as Exhibit A, shall be hereby adopted and shall be effective April 20, 2019.
4. Resolution No. 2009-169 adopted September 14, 2009 and Resolution No. 2010-141 adopted September 8, 2010, which previously established fees for classifications of waste materials accepted at the West Nassau Convenience Center, are hereby rescinded.


