A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS EXTENDING THE STATE OF EMERGENCY IN NASSAU COUNTY, FLORIDA DUE TO COVID-19

WHEREAS, the seven (7) day increment may be extended by a majority vote of the Board of County Commissioners of Nassau County, Florida; and
