WHEREAS, Michael Favors, in all his endeavors, has reflected great credit upon the County; and

WHEREAS, Michael Favors announced his retirement effective May 28, 2021; and

WHEREAS, Michael Favors will be greatly missed by those who had the honor to work with him, as well as the citizens of Nassau County.

by the Board of County Commissioners of Nassau County, Florida, that:


1. The Board publicly commends Michael Favors for his outstanding service and dedication to Nassau County.


