A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, AMENDING THE NASSAU COUNTY AMERICANS WITH DISABILITIES ACT (ADA)/504 TRANSITION PLAN IN NASSAU COUNTY.

WHEREAS, the Nassau County Board of County Commissioners approved Resolution 2019-155 which adopted the Nassau County Americans with Disabilities Act (ADA)/504 Transition Plan, as amended; and

WHEREAS, it has become necessary to amend the Nassau County Americans with Disabilities Act (ADA)/504 Transition Plan, by designating a new ADA Coordinator in Section VI. Designation of ADA Coordinator and in Section VIII. Grievance Complaint Procedure.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Nassau County, Florida, that the Nassau County Americans with Disabilities Act (ADA)/504 Transition Plan is hereby amended as follows:

1. Section VI. Designation of an ADA Coordinator

2. Section VIII. Grievance Complaint Procedure






