

RESOLUTION NO. 2025-144

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, ESTABLISHING A 25 MPH SPEED LIMIT ON YANIE ROAD; AUTHORIZING STAFF TO INSTALL 25 MPH SPEED LIMIT SIGNS ON YANIE ROAD; PROVIDING FOR FINDINGS BY THE BOARD OF COUNTY COMMISSIONERS; PROVIDING FOR PENALTIES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 316.006(3), Florida Statutes, provides that Nassau County has original jurisdiction over all its streets and highways located within its boundaries, except all state roads and municipal streets and highways, and may place and maintain such traffic control devices which conform to the specifications of the Florida Department of Transportation upon all streets and highways under their original jurisdiction as they shall deem necessary to regulate, warn, or guide traffic; and

WHEREAS, Section 316.189 (2), Florida Statutes, further provides that local authorities may, with respect to streets and highways under their jurisdiction, exercise the police power to regulate speed limits; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, finds that it is in the best interest, safety and welfare of the citizens of Nassau County to establish a speed limit of 25 MPH on Yanie Road and authorize staff to install 25 MPH Speed Limit signs on Yanie Road.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Nassau County, Florida, as follows:

SECTION 1. FINDINGS.

The Board of County Commissioners has examined the recommendation by the Department of Development Services in relation to, and based upon the investigation, hereby determines that it is in the best interest, safety and welfare of the citizens of Nassau County to establish a 25 MPH speed limit on Yanie Road and install 25 MPH Speed Limit signs on Yanie Road.

SECTION 2. PENALTIES

Any person found guilty of violating the 25 MPH speed limit established by this Resolution shall be punished according to the provisions of Section 316.189(4), Florida Statute, and Chapter


318, Florida Statute.

SECTION 3. EFFECTIVE DATE.

This Resolution shall take effect immediately upon installation of the 25 MPH Speed Limit signage on Yanie Road and shall expire upon the removal of said signs.




